



Camp Kennebec Enrolment Terms & Conditions

Definitions:

Camp Kennebec (Frontenac) (1979) Inc. and its representatives (“CK”)

Child, Children (Camper)

Parent or Guardian (Parent)

Him or Her (Him)

1. Application Process

- Parent signing this document represents and warrants that parent has the right to enter into this agreement and enroll camper in CK. Parent also agrees to pay all published CK fees by the due dates. Parent acknowledges that failure to pay CK fees on time may result in incremental interest or other charges, forfeiture of deposits and other payments received and non-attendance at CK.
- Upon receipt of camper’s application and deposit, CK will confirm camper’s enrollment. It is the parent’s sole responsibility to read all forms carefully, complete them accurately and sign where required. CK’s acceptance of camper is contingent upon CK’s receipt and review of all forms. These forms contain important information about program activities and associated risks, as well as parent and camper responsibilities.

2. Fees and Terms of Payment

- Terms of payment are as described in the registration form. Please see the CK website (campkennebec.com) for details. Parent payment covers the cost of lodging, meals as indicated and group activities. CK reserves the right to add reasonable surcharges to cover unexpected cost increases.
- If parent fails to pay any sum due hereunder by the due date, CK reserves the right to charge and parent agrees to pay interest at the rate of 1.5% per month (18% per annum) on any sum outstanding, and any other costs that CK may reasonably incur in the collection of outstanding debts.

3. Camper Medical, Dental or Other Costs

- As required, CK engages qualified personnel to provide campers with medical, dental or other health-related services. Parents agree to reimburse CK for all medical, dental or other expenses and charges.



4. Adherence to Camp Rules

- At its sole discretion, CK will establish rules and regulations to protect camper's well being, while providing a safe, fun environment for all campers. Campers and parents agree to comply with all CK rules and regulations, with the understanding that failure to comply may result in dismissal. CK may dismiss campers who present a safety or medical risk to himself or herself, are disruptive or uncooperative, or whose overall behaviour and comportsment is detrimental. There will be no fee refund if a camper leaves the CK program for any reason, including dismissal. Parents are responsible for all early departure costs, including transportation.

5. Photo Permission

- Parent permits CK to use camper's likeness and voice for advertising, publicity or other uses.

6. Lost, Stolen or Damaged Property

- CK bears no responsibility for lost, stolen or damaged camper items.

7. Program Withdrawal, NSF Cheques, Refunds & Program Changes

- Parents may withdraw their CK applications by providing CK with written notice before December 31, 2013 and receive a full refund. Notifications received between January 1 and February 28, 2014 will receive a full refund less a \$250 administration fee. Withdrawals after February 28, 2014 will not result in any refunding of fees.
- CK will charge a \$100 administration fee for NSF cheques and will then require all payment by certified cheque, money order, bank draft or electronic funds transfer.
- If necessary, CK reserves the right to change or alter program itinerary, location, dates or duration. CK is not responsible for costs a parent may occur due to the change.

8. Severability

- It is the intention of the parties that, if any provision of this document is invalid or unenforceable in any respect, such provision shall be enforced to the maximum extent permitted by law, and that the remaining provisions of this Agreement shall continue in full force and effect.



9. Applicable Law and Venue

- Ontario law governs this document and all aspects of parent and camper relationships with CK.

10. Dispute Resolution

- In the event of a dispute, representatives of the parties with decision-making authority will meet to negotiate, in good faith, a resolution of the dispute. The parties agree to file, make or enter all claims in a court of competent jurisdiction in the County of Frontenac, Ontario.

11. Completion, Permission to Participate
